**3. Project Intent:** Normative – International Standard

## 4. Project Purpose

a. Why this project is needed – justification

Many ISO member national bodies/HL7 realms have already begun using the HL7 EHR-S FM Release 1.0 for national initiatives in their respective countries. For example, in the US, various profiles from the EHR-S FM have been submitted to the Certification Commission for Healthcare Information Technology (CCHIT), which has used conformance criteria in these profiles as a model for their certification criteria. Other ISO national member bodies/HL7 realms have used the EHR-S FM to help develop functional requirements in areas of care (e.g., diabetes care in the Netherlands), certification (Ireland, Canada), and setting national HIT standards (Brazil, Germany, Japan, Canada), and more. The heavy usage of the EHR-S FM by these ISO member bodies/HL7 realms have caused the FM to be balloted in both ISO and HL7 processes as Release 1.1 (ISO FDIS 10781 expected in Oct/Nov of 2009). These ISO member national bodies/HL7 realms want to increase the functionality of the FM, which requires the enhancement of the model as Release 2.0 (currently underway).

#### b. Why this project should be JIC

The ISO national member bodies/HL7 realms have requested Release 2.0 to be balloted as a JIC initiative. A JIC initiative would make the balloting and reconciliation processes between ISO and HL7 more efficient and lend greater credence of the FM to the customers of the ISO national member bodies/HL7 realms.

#### c. What is the market need for this standard?

As noted in the response to item 4a, there is already heavy usage of the EHR-S FM among ISO national member bodies/HL7 realms. A joint ISO/HL7 standard balloted as a JIC initiative will lend greater credence of the FM to the customers of the ISO national member bodies/HL7 realms, and thus increase the usage of the FM.
